The Building Fund savings has a balance of \$15,595.00. Dave Jaeger made a motion to approve the treasurer's report. Matt Haschke seconded the motion. The motion carried.

Vouchers Paid

Vouchers paid since the last meeting totaled \$20,202.84. A detailed list was emailed to each Director. Jeff Farran made a motion to approve the vouchers. Matt Haschke seconded the motion. The motion carried.

Old Business

Clean up derby remained tabled from previous meeting.

New Business

- Karissa Pollack was present and requested the use of the Expo Building on June 24 and 25, 2022 for a wedding reception. Jeff Farran made a motion to allow her the use of the building. Andy Nelsen seconded the motion. The motion carried.
