- Review Livestock Committee Meeting.
  - No bedding will be supplied this year other than for the show arenas. All bedding must be of a woodchip style. NO cornstalks (except for Cow/Calf pairs), grass, straw, etc. The base layer of woodchips for the beef/dairy barn will be supplied, the overlay woodchips will be supplied by the 4-Her.
  - Due to the smoke and noise last year at the tractor pull, a discussion was held regarding the horse barn. Dave Jaeger made a motion to allow the horses to be dismissed at 4 PM Friday evening and MUST return by 8 AM Saturday morning to be eligible to receive their premiums. Matt Haschke seconded the motion. The motion carried.
- The Christmas Parade of Lights will be held November 18 at 6:30 PM. All members that can make it are asked to be at the fairgrounds at 5 PM to help set up the float.
- The entertainment for the concert the 2022 fair will be announced on the view and at the Parade of Lights. Gary Allan and Randy Houser will be featured at the concert.
