#### Roll Call

#### Minutes

A motion was made by Merlin Felt and seconded by Dave Jaeger to approve minutes of the previous meeting as emailed to the members. The motion carried.

#### Treasurer's Report

• The treasurer reported \$43,793.61 in Checking and \$845.86 in Savings and ATM-\$15,680.00 for a total \$60,319.47. The Building Fund Savings balance is \$16,725.00 A motion was made by Jeff Farran and seconded by Matt Haschke to approve the treasurer's report. The motion carried.

#### Vouchers Paid

Vouchers paid since the last meeting totaled \$411,584.52. A detailed list was emailed to each Director. A motion was made by Dave Jaeger and seconded by Rod Gilliland to approve the vouchers. The motion carried.

#### **New Business**

- Julie Schultz was present and thanked the board for everything. They really enjoyed being moved to the Expo Center for the 4-H/FFA Static Exhibits. They would like to remain in that building. The Style Show worked very well, and they had a very good attendance.
- Mandi Fernau was present and requested the use of the Expo Center on either May 8<sup>th</sup> and 9<sup>th</sup> or May 15-16, 2026, for Regan's graduation. A motion was made by Jeff Farran and seconded by Trever Hartmann to approve the request. The motion carried.
- There was an email received from Buryanek's regarding the walnut tree by their back yard. They had some limbs blown down into their yard. Shane Frahm will be contacted to look at the tree and possibly remove it.
- Concert for 2024—Pricilla Block has been booked. Kevin has been in contact with Romeo to find another act to go with her.

- Merlin Felt had visited with Stephanie regarding the Lonnie Weinrich Memorial. She indicated that there would be about \$1,500. It was mentioned that the purchase of a Big Ass Fan or something smaller to hang in the Leland Herman Building with a plaque.
- A discussion of beer coolers for the fair was held. It was discussed about building portable
  coolers ourselves or purchasing some. Wayne Cedar and Knox Counties would be interested in
  going together and each fair purchases 3 coolers. They would then be shared with all 3 counties.
  A motion was made by Trever Hartmann and seconded by Kevin Davis to look into the price of
  purchasing coolers. The motion was carried out, and the beer committee will report back.

A motion was made by Matt Haschke and seconded by Todd Greunke to recess the meeting for the budget meeting.

The meeting reconvened.

- A discussion was held regarding dirt in the beer garden. The area needs to be leveled. The power lines are only about a foot deep, so would have to watch out for those. Also discussed using blocks to retain.
- A discussion was held regarding lights on the west side of the bleachers. Until things are more permanent, use lights with LED's.
- Security was discussed and everyone seemed satisfied with Bulwark Security.
- Rain gutters on the office building were discussed. Pricing will be obtained and reported back to the board.
- Kristine Nieman's cleaning expenses was discussed. A motion was made by Andy Nelson and seconded by Rod Gilliland to leave the same as last year with the same bonus. The motion carried.
- St. Mary's Food Stand sent another 5-year contact for the same amount of \$300.00 rent per year. A motion was made by Jeff Farran and seconded by Andy Nelsen to accept the contract renewal.
- Dave Jaeger requested the use of the Expo Center for August 2, 2025, for a family reunion. A motion was made by Trever Hartmann and seconded by Matt Haschke to approve the use of the building. The motion carried.
- A discussion was held regarding adding more Porta-Pots around the grandstand. Could use 6-8 more or another trailer load. Another option discussed was building restrooms.
- A discussion was held regarding adding additional sinks in the women's 4-H restroom. There is currently only one and normally a waiting line.
- The skid loader from CAT which was used during the fair had the forks damaged. We purchased a set to replace the damaged ones for \$900.00. The damaged forks are getting repaired and will then stay at the fairgrounds. CAT requested that their skid loader not be used at the derby.
- Fair dates for 2024 will be July 25-28.
- It was noted that the Side-by-sides that are loaned to us during the fair need to be power-washed and refilled with gas before they are returned.
- A large thank you to Randy and Lesa Jensen for the use of the Refrigerator trailer for the beer garden.

A motion was made by Trever Hartmann and seconded Matt Haschke to adjourn the meeting.
