Old Business:

Convention—Everyone needs to have their registration to Diane Roeber by December 24th so that we can get registered under the early-bird discount. Kevin will check to see if the bus is available to take.

New Business:

- Darrin Greunke from Sharp Shooters 4-H Club would like to reschedule their Tri-Athlon for either June 8 or June 22, 2019. They would like to use the 4-H Building and Leland Herman Building. Jeff Farran made a motion to approve the request. Cody Henderson seconded the motion. The motion carried.

- District 3 will be hosting the hospitality room at the Nebraska Fair Convention. We will need to provide at least ten door prizes, treats and volunteers to work.
- Kevin Davis mentioned that the Mini-rod pickups will not at the pull this year. There will be Diesel pickups.
