GENERAL RULES

There will be a charge of \$1.50 per stall. All applications for entries must be made upon printed forms which may be obtained free by writing the secretary. These forms are to be filled out and signed by the exhibitor. All cattle must be haltered and led to shows to be eligible for premium, all others will be considered as a commercial exhibit. **REFER TO HEALTH REQUIREMENTS UNDER GENERAL RULES.** Exhibitors must keep the space in the rear of their stalls clear and clean. All offal must be thrown where indicated by the superintendent of the department. Any violation of this rule will subject exhibitor to expulsion from the grounds. All stock and camper trailers will be parked in their designated areas. Exhibitors must keep their stalls open and stock uncovered from 1 p.m. to 6 p.m. during each day of exhibition. Exhibitors are expected to comply with the superintendent promptly in producing their stock as directed. Stock must be in the ring within ten minutes after the class is called. Any person failing to comply with this rule is not an exhibitor for the premium offered. Exhibitors will show their animals at such times and places as may be directed, and shall furnish such information concerning their stock as may be required by the superintendent, and in case of refusal noncompliance with this rule any or all premiums will be forfeited and the exhibitor barred from showing.

Milking out: In the dairy classes it shall be the duty of the superintendent or his assistant to see that all cows have been milked out clean not earlier than 5 p.m. of the day preceding the judging.

Class B1 — BEEF CATTLE

A bull over one year old without a ring in his nose may be excluded from the show at the discretion of the superintendent.

OPEN CLASS FEEDER CALVES

Wayne Co. Special; Premiums will be paid to the first three placings in each class, shown by Wayne County Exhibitors. Premiums will be paid as follows: 1st Place — \$13; 2nd Place — \$11; Third Place — \$9.

There will be cash awards given for Champion and Reserve Champion in each division. All calves will be released after the show. All calves will be shown loose in the class pen. Open class feeder calves, entry fee \$5.00 which does not include required gate pass. Entries close 11:00 a.m., Saturday of the current fair year. Make entries to Beef Superintendent.

To qualify calves must be born after January 1, of the current fair year. There are four divisions in this class – 1 for steers, 1 for bulls, 1 for breeding heifers, and one for feeder heifers. Classes will be divided after all entries are in and weighed. There are no breed divisions. Premiums to be paid first five places in each class, with 100% payback of entry fees prorated. No grooming or boning will be permitted.

MARKET HOG CLASS

Open to 4-H and Open Class exhibitors. All hogs must be in place by 6:00 P.M. on Wednesday of the current fair year.

There is no entry fee. Market Hog recommended weight: 220 to 280 pounds.

The Open Class market hog show will be judged by an ultrasound. Results will be posted at 4-H office and Swine Barn. Checks will be awarded at the Bonus Auction.

GENERAL RULES

Entries close Wednesday of the current fair year at 8:00 p.m.

Sheep pen fee is 75¢ per animal. Application for pens to be made to the secretary. Assignments will be made by the superintendent of the department as soon after entries close as practicable. Pens will not be held unless application is accompanied by required fee.

Ages of animals will be reckoned as follows.

Fall Lamb — born Sept. 1, 2022 - Dec. 31, 2022.

Spring Lamb — born Jan. 1, 2023 or later.

Yearling — one year of age and under two years.

Sheep must be owned by one individual or previous existing firm at least 30 days prior to the fair. Judges, in making awards, must record ear tag as well as entry number of all animals awarded prizes.

All exhibition animals must be recorded, or descended from recorded sires and dams. Failure on the part of an exhibitor to furnish sufficient evidence that his sheep are eligible under this rule, to the satisfaction of the superintendent or judge, will disqualify all animals whose breeding is held in doubt.
