- Discussion was held regarding a donation to the local EMS and fire departments for their volunteer services during the fair. It was further discussed that one of the wood Carver items would be donated back to these volunteer units.
- Discussion was held regarding our identification badges board members were asked to check their badges to make sure that they were still valid. If they had expired, they need to contact Nic to get them replaced.
- Discussion was held regarding the purchase of additional fire extinguishers so that we would have two per building. Craig Reeson will check in on getting five more extinguishers.
- Discussion was held regarding placing a Nebraska statewide classified ad. It would be in 73 statewide papers A two by four ad would cost \$650 or a two-by-two ad would cost \$325. The item died for lack of emotion.
- The Nebraska state fairs County Fair day will be held on August 24th. The parade will be at 1:00. Jim Fernau will look into getting tickets and will participate that day.
- The State Fair has contacted us and requested a time that they should come and help with the fair. It was decided that Friday July 26th would be the best date and they could help with the beef show, the barbeque, or in the beer garden as needed.
- Brent and Bob Sherman were present to discuss the Demo Derby. They suggested a new
  prize list for Bone Stock and the 90s and Newer classes and also adding more money to
  the Mad Dog. They will try to get sponsors to increase the Mad Dog money. A motion

  suggested for a total amount of \$350.00. The motion carried.

- Meet later to talk about changes and to make notes of what needs to be addressed and how it can be changed. Get a game plan ready before starting anything.
- Overall, the pre-sales, gate and beer garden did well. The carnival price hurt our overall net income.
- Would like to have a Refer or building for beer and ice. Open to suggestions on what would be the best option. Jeff Farran will get estimates on a 12' x 40' or a 14' x 50' with a one-slope roof line with a concrete base and insulated walls.
