New Business

• Ron and Diane Gentrup were present and requested the use of the Expo Center for a shower on September 14, 2024. A motion was made by Cody Henderson and seconded by Todd Greunke to allow them the use of the building. The motion carried. Will have Diane Rober get him the contract and keys.

- It was brought to the board's attention that there are some damaged tables in the Expo Center. The suggestion is to wait until 2025 and either replace or fix the tables.
- A motion was made by Jim Fernau and seconded by Merlin Felt to pay Kristine Niemann a bonus of \$750.00 for cleaning. The motion carried.
