New Business

- Desi Irish and Margo Reeson were present in the place of Julie Schultz to discuss the addition of a 4-H Rodeo on Saturday morning of the fair. A proposed agenda of events was presented to each board member for review. A motion was made by Dave Jaeger and seconded by Merlin Felt to add the event to the fair schedule. The motion carried.
- The need for an upgrade of the rabbit cages was brought up in the Livestock committee meeting. Craig Reeson reported that they would like to have all wire cages for better airflow for the rabbits. Also, the cage size is large for birds, but the doors are not big enough for the kids to get the bird. out safely. A motion was made by Trever Hartmann and seconded by Jim Fernau to table the matter until the next meeting so that estimates of materials could be obtained. The motion carried.
- 2026 camping fees during the fair week was discussed. It is currently \$150/week. A motion was made by Kevin Davis and seconded by Jim Fernau to leave the rate the same. The motion carried.
- The storage fee for boats and campers for the 2025-26 season was discussed. The rate is currently \$220 for the period of October-April. A motion was made by Kevin Davis and seconded by Brad Roberts to raise the rate to \$250.00. The motion carried.
- A discussion was held regarding the Open-carry law for firearms. It was decided that as long as they are being carried legally, it will be allowed on the fairgrounds.
- The Parade of Lights will be held November 21 at 6:30 pm. Anyone that can help put the float together is asked to meet at 5:00 pm at the fairgrounds. Matt Haschke will arrange the pickup and trailer. Cody Henderson will bring in his speaker.
- Discussion of Corporate Sponsor levels was discussed, and it was decided that they would be left the same.
- Kevin Davis gave an update on the entertainment for 2025. They are 99.9% sure that the contract will be signed for the act that the bid was placed on. Tegan Nissen has been booked to be the opening act and will also work in the beer garden the same night.
- Bob and Brent Sherman were present and gave the board a check for the rent of the track for the derby. They requested the date of September 27, 2025, with rain date of October 4, 2025. A motion was made by Jeff Farran and seconded by Rod Gilliland to approve the dates requested. The motion carried.
- Discussion was held regarding the rent on the Expo building. Nothing was decided at this time.
- An audit committee of Dave Jaeger, Brad Roberts and Andy Nelsen met with Treasurer, David Ley, and Secretary Diane Roeber to complete the audit of the 2023-2024 records. A motion was made by Merlin Felt and seconded by Cutter Habermann to accept the audit committee report. The motion carried.
- Discussion was held regarding the track and dirty work that needs to be done. Terry Sievers has done a survey and the dirt is there, it just needs to be pulled into different areas to allow for better drainage. It will be seeded as soon as they are finished. They will also fill in the low spots behind the bleachers and get that re-seeded also.
