A motion was made by Rod Gilliland and seconded by Todd Greunke to approve the additions to the agenda. The motion carried.

A motion was made by Todd Greunke and seconded by Dave French to approve minutes of the previous meeting as emailed to the members. The motion carried.

Treasurer's Report

• The treasurer reported \$8,548.93 in Checking and \$36,045.61 in Savings and ATM-\$2,100.00 for a total of \$46,694.54. The Building Fund Savings balance is \$17,020.71. A motion was made by Kevin Davis and seconded by Trever Hartmann to approve the treasurer's report. The motion carried.

Vouchers Paid

Vouchers paid since the last meeting totaled \$7,818.86. A detailed list was emailed to each
Director. A motion was made by Dave Jaeger and seconded by Merlin Felt to approve the
vouchers. The motion carried.

Old Business

New Business

- A discussion was held regarding the fire extinguishers. Were any used for the clean-up derby and do they need re-charged? Cody indicated that he would call Phil and get this matter taken care of.
- Cell Tower—The paperwork for the sell has been signed and we should be getting the funds within a week or so.
- Kevin Davis informed the board that the entertainment should all be good to go and he has informed Romeo that it will NOT be paid for by the board and there will be NO shuttle service provided if they book rooms outside of Wayne.

- Davis Ford will be a Diamond Sponsor this year and was requesting room to bring some of their
 used cars out to park in a building if the weather gets bad and they would need to get cars into a
 shelter. A motion was made by Kevin Davis and seconded by Jeff Farran to approve the use of
 the Leland Herman Memorial Arena to shelter cars in severe weather. The motion carried.
- A list of projects to be completed will be posted.
- Comhole tournament will be run by Zac Braun this year. They have requested that the area the boards are set on be leveled out. Will contact the county to level the playing area.
- Trever Hartmann will contact the county to get the track work done. The fence on the south end will be removed and a permanent berm will be made. Grass will be planted with an overlay to hold the seeding and then the fence will be reinstalled. The county will also work the track for better drainage.
- Ben Braun was present and requested to advertise on a chute if one is available. Kevin Davis will check his list of sponsors and let him know.
- The new derby class was discussed. There will be a limit of 15 teams, and we must have 10 teams to hold the class. The cost to participate will be \$450/team and they must register with CS Promotions before July 1st. This will be running as one heat and done. A motion was made by Andy Nelsen and seconded by Kevin Davis to approve a payback for this class as 1st-\$6,000, 2nd-\$3,000 and 3rd-\$1,000.
