Treasurer's Report

The treasurer's reported \$98,906.36 in checking, \$103,737.62 in savings and \$2,860.00 in the ATM for a total of \$205,503.98. The building fund savings balance is \$17,063.18. The funds from the cell-tower lease buy-out in the amount of \$124,693.75 is being held. A motion was made by Todd Greunke and seconded by Trever Hartmann to approve the treasurer's report.

Vouchers Paid

Vouchers paid since the last meeting totaled \$113,857.01. A detailed list was emailed to each director. A motion was made by Jeff Farran and seconded by Rod Gilliland to approve the vouchers. The motion carried.

New Business

- County Fair day at the state fair. Registration is due by July 18. It was agreed that ten tickets for Saturday, August 23rd will be ordered for use by the fair board.
- Asphalt from the 4-H concession building to the south gate. Doug Temme received two estimates
 for cost of the project from Midwest Coating Company, Inc. One for \$69,608.00 and one for
 \$58,423.00. He also received an estimate from Knife River in the amount of \$82,636.43. The
 board will continue to get bids for the project. By doing this, they are hoping to end the erosion
 created by the walking trail when it rains.
- Julie Schultz would like to the boards approval to have the 4-H UNL Dairy Ice Cream Truck at the county fair. Todd Greunke will visit with Julie and see what they would need for electrical hook-ups.
- Kevin Davis will meet with Chase at Northeast Nebraska Insurance to make sure that all is in order for the fair coverage for the year.
- Ross Rastede is available to do drone footage for two hours each day of the fair for coverage of
 the main events. He will charge \$200 per day. A motion was made by Jeff Farran and seconded by
 Cutter Haberman to hire him. The motion carried.
- Diane Roeber reported that on the last bill from Fast Pik that there would be \$5/month service
 charge on all charge accounts. It was decided that since they were not a corporate sponsor this
 year, we would switch to Fredrickson Oil Co. for our fuel needs.
- Kayla at the Wayne Herald is holding a front page "Fun in The Sun" ad space for an ad in the shopper. A motion was made by Matt Haschke and seconded by Kevin Davis to approve the ad in the shopper. The motion carried.
- Doug Temme presented a list of meeting dates for the Manure Expo that will be held next year after the fair on the fairgrounds. The meetings will be once a month starting on September 24th at 9:00 AM on Zoom. All interested parties can meet at the fair office to sign into the meeting.
- Brad Roberts will be getting the radios from Don again this year. He will pick them up on the 21st.
- The new chair racks for the 4-H/Expo Center have been ordered and should be here before the fair.
- Jeff Farran asked if the Winside Cheerleaders could do a fundraiser at the fair. They would like to do a dunk tank. After a discussion, it was agreed that they could do a dunk tank.
- The large screen TV's we received from the state fair have all be mounted on tailers and Jeremy with Sure Sound and Lighting will be here to help get them set up for the fair. We may need some extra cables and boxes to get the ready.
- An Impact study is being done by the iafe. We will find out for sure what it will cost for us to get a copy of the reports after information has been submitted.
- Amand Koehler's church group is willing to run the concession at the horse arena for the 4-H Rodeo. It will be a fund raiser for their group.
- Bob Sherman was present and ran an idea by the board. They are interested in holding a banquet similar to Pheasants Forever to raise money for the cleanup derby. Sell tickets individually and as a table. Something to think about to earn money for scholarships.

A motion was made by Cutter Haberman and seconded by Trever Hartman to recess the meeting to the Monday before the fair. The motion carried.

Call to order by President, Doug Temme at 8:36 p.m. on July 21st. The meeting of July 10th was reconvened.

- Discussion was held regarding the need for additional Port-a-Pots for the fair. It was agreed that eight more could be used between the Beer Garden and Grandstand area.
- Discussion was held regarding the budget request for the year 2025-2026. A motion was made by Todd Greunke and seconded by Cutter Haberman to submit a request for an additional 1% allocation. The board members voting to approve the request were Merlin Felt, Matt Haschke, Dave Jaeger, Todd Greunke, Brad Roberts, Trever Hartmann, Craig Reeson, Jeff Farran, Andy Nelsen, Jim Fernau, Cody Henderson, Dave Jaeger, Kevin Davis, Cutter Haberman, Doug Temme, Rod Gilliland, and Shelli Keiser. There were no Nay votes. The motion carried.
- A motion was made by Jeff Farran and seconded by Kevin Davis to approve the request of \$200,000.00 from the commissioners, which is an additional \$125,973.81. The board members voting to approve the request Merlin Felt, Matt Haschke, Dave Jaeger, Todd Greunke, Brad Roberts, Trever Hartmann, Craig Reeson, Jeff Farran, Andy Nelsen, Jim Fernau, Cody Henderson, Dave Jaeger, Kevin Davis, Cutter Haberman, Doug Temme, Rod Gilliland, and Shelli Keiser. There were no Nay votes. The motion carried.
- Several of the board members will meet with the commissions at their next meeting on August 19, 2025.
- Sherman's are going to leave the 2-man class open, and the pay-out will be pro-rated depending on the number of entries.
- The county will be in to drag the road and sweep the sidewalks on Tuesday morning.
- The roads will be sprayed this week to eliminate dust for the fair.
- Danny Bruns or Adam Sellin will be contacted to spray with a drone for flies and bugs.
- Mark Gram will be here for Romeo Entertainment.
- Next year, we will investigate cancellation insurance for the concert.

A motion was made by Kevin Davis and seconded by Cutter Haberman to recess the meeting until later in the fair. The motion carried.

• Midwest Rides is breach of their contract. They were to bring 8-10 rides and 8-10 concession/games. They have seven rides and one bounce house. They only have three concession wagons. They indicated that we had \$5,700 in pre-sale voucher from the QR codes. They indicated that if they did not get paid in full \$52,500 less the \$5,700 in pre-sales, they would load up all their rides and leave the fairgrounds. The board contacted both our local attorney and the state fair boards attorney regarding this matter. It was decided that we would pay them in full so we a least had a carnival for the fair. We may decide to pursue the matter after the fair.

A motion was made by Kevin Davis and seconded by Jim Fernau to recess the meeting. The motion carried.

The meeting was reconvened by Vice President, Merlin Felt on July 28 at 7:52 PM.

New Business

- Kinship would like to use the big blue golf cart to take clients for a ride around the golf cart to get them out. A motion was made by Jeff Farran and seconded by Jim Fernau to approve the use of the golf card. The motion carried.
- Midwest Rides. We paid them \$4,000.00 for the wristband for the Perfect Attendance rides on Sunday. The amount of \$7,113.00 was withheld from the tickets for corporate sponsors and balance due back on the wristbands. It was decided that if they pursue the issue, we will then bring it up again with our attorneys.
- The preliminary income received for the fair is approximately \$64,000.00.
- The woodcarvings brought in \$15,150.00. It was agreed that the highest priced item (\$2,150.00) would be again divided between the five fire and rescue units that volunteer their time and equipment each year to help at the main events of the fair.
- Thunder by the River would like to use our big blue golf cart to transport handicap visitors. It was
 determined that a \$500 deposit \$100 per day would be charged for the use of the cart. A motion
 was made by Andy Nelsen and seconded by Rod Gilliland to approve the use of the cart. The
 motion carried.
- Parking on Saturday night was discussed. Exit from the parking lot, one going north and one going south. Table to August meeting to further identify logistics.
- With the golf carts being returned this week, we have the option to trade off the Solar golf cart for \$2,500 for either the 2019 golf cart for \$6,050.00 or a 2023 golf cart for \$7,440.00 from Miller and Sons. A motion was made by Dave Jaeger and seconded by Rod Gilliland to trade for the 2023 golf cart. The motion carried.
- It was brought to the attention of the fair board that if someone breaks equipment, please let someone know or if you do not know how to run the equipment, please ask.
- Kevin Davis is working on entertainment with Romeo Entertainment for the 2026 fair. He has put in a bid and will let us know if it gets accepted.
- Kevin Davis will pursue the contact with Mac Amusements for a three- or five-year contract.
- Discussion was held regarding a tent for Love-A-Lops for next year.

A motion was made by Jeff Farran and seconded by Craig Reeson to adjourn the meeting. The motion carried.
